### PERSONAL PROTECTION

- A Hard hat, safety glasses, and hearing protection must be worn while in Construction and posted areas and as instructed by SVWRF personnel.
- Hearing protection must be worn in posted areas or when informed to do so by SVWRF personnel.
- Use other personal safety equipment as required when hazards exist or as directed by SVWRF personnel.
- Stay in your designated visit or work area.
- Access to areas designated as "Restricted" or "Authorized Only" is prohibited unless accompanied by SVWRF personnel.
- Obey all posted warning and safety signs.
- Practice proper personal hygiene while onsite. Wash hands often and before eating, drinking or smoking.
- Eat and smoke only in designated areas.
- Use POTABLE WATER sources only for drinking and personal hygiene.
- DO NOT drink from or use utility water sources for personal hygiene (i.e. hoses, sprinklers, etc.).

#### HAZARD RECOGNITION

- Always be alert for potentially hazardous conditions.
- Be aware of trucks, mobile equipment, and other traffic as they always have the right of way on Facility property.
- Maintain a safe distance from moving vehicles, equipment and stay clear of suspended loads.
- A variety of potentially hazardous chemicals may be present. Review MSDS's and Hazard Labels for safety information.
- Be alert and respond immediately to warning signs and alarms as directed.
- Do not operate any SVWRF vehicle, equipment, or machinery without prior authorization from SVWRF directing authority.

#### **VEHICLE OPERATION**

- Seat belts must be worn at all times while riding in or while operating a state or federally registered motor vehicle on SVWRF property.
- Obey all posted speed limits and traffic control devices and drive according to conditions.
- Use of cellular devices is prohibited while operating a state or federally registered motor vehicle on SVWRF property.

#### SECURITY

- The consumption, possession, or being under the influence of any drug or alcohol is prohibited on SVWRF property.
- Firearms and/or Explosives are not permitted on SVWRF property without written permission from the General Manager.
- Use of combustible, caustic or potentially hazardous material on facility property must be pre-authorized by SVWRF General Manager.
- All vehicles must be parked in the lot west of the Administrative Building unless designated otherwise by SVWRF personnel.

### IF YOU ARE IN DOUBT ABOUT ANY PROCEDURE OR HAZARD, DISCUSS IT WITH YOUR DESIGNATED SVWRF CONTACT.

FAILURE TO FOLLOW SVWRF SAFETY AND SECURITY PROCEDURES WILL RESULT IN REMOVAL FROM SVWRF PROPERTY AND REVOCATION OF SECURITY BADGE.
