QUESTIONS RECEIVED:

1. Will a cashier's check for 5% of the Bid Amount be acceptable in lieu of a bid bond? Yes. The bid security section has been updated to show 5% is the correct amount.
2. Is the Contractor responsible for providing sanitary restroom service to their employees? Yes. Bidders are instructed to provide port-a-potty rentals in their bids for their employees along with trash removal, hand cleaning stations, and other hygiene related items their employees may need.
3. When will bids be opened? Bids will be opened at 2:00 PM on July 8, 2021 at the office of SVWRF. Contractors may attend in person. Please arrive early. No bids received after 2:00 PM will be accepted.
